**Committee Volunteer List**

Instructions: Please examine the following committees and be prepared to chair or work on the committee that interests you or you want to learn more about to become a well rounded Sigma Man. These committees will be formed on Friday evening at the Executive Board Meeting.

**Auditing Committee** *(This committee inspects the books and accounts of the State Treasurer, and all other Officers of the State Board. The financial records of such officers must be submitted to the Auditing Committee on the first day of the Conference together with expense vouchers, bills, receipts, etc., reflecting the receipts and disbursements of his office. The Committee reports its findings to the Conference)*

**Budget Committee** *(This committee is a standing committee that reviews proposed budgets of all State Board Officers that are submitted to the State Executive Board at the meeting at which such Budgets are to be acted upon by the Executive Board.)*

**Law and Revision Committee** *(This committee reviews all proposed amendments to the Constitution and By-Laws and reports its recommendations to the Conference.)*

**Grievance Committee** *(This committee reviews all grievances referred to the Conference by either chapters or members for disposition. It shall review all requests for suspension or expulsion of members, and report its findings and recommendations to the Conference for disposition.)*

**Credentials Committee** *(This committee shall review the credentials of every Delegate to the Conference and prepare a list of Official Delegates and chapters for presentation to the Conference not later than the second hour of the Conference.)*

**Resolutions Committee** *(This committee gathers written resolutions regarding any matter pertinent to the policies of the Fraternity. The written resolutions must be submitted to the State Secretary.)*

**Necrology Committee (Omega Chapter)** *(This committee shall report to the Conference the names of all Fraternity Brothers who have died since the last meeting of the Conference. It shall conduct a non-sectarian memorial service at the Conference to honor such deceased Brothers of the Omega Chapter.)*

**Time and Place Committee** *(This committee researches the feasibility of the next Conference Host on the list established at previous Conferences to be the host. The Committee also extends the list of future hosts of the State Conference by considering past schedules, and recruiting and selecting future hosts.)*

**Conference Evaluation** *(To solicit and collect feedback about the conference)*

**Collegiate Affairs Committee** *(This committee is a standing committee that has the duty of keeping the Fraternity and State Executive Board informed on the status of collegiate chapters, and shall suggest programs and projects of the development of such chapters.)*

**Chapter Reports and Awards Committee** *(This Committee reviews Chapter Reports, makes recommendations for improving the Report, and select a way of honoring Reports that deserve recognition for their excellence. The Committee also nominate individuals for a Collegiate Hall of Fame in Academics, Athletics, Leadership.)*
